Building construction management

The TCC Center for Innovation (CFI), located in Kleman Plaza in downtown Tallahassee, is a tenant-occupied 4-story facility. The primary structure of the building consists of poured in place concrete floor systems with one elevator and two exterior stair shafts.

TCC is requesting SOQ's from licensed general contractors who wish to provide submittals for Construction Management (CM) at Risk services for the interior renovation of the TCC Center for Innovation (CFI) campus, located at 300 West Pensacola Street in Tallahassee, Florida.

The Construction Manager shall provide all Preconstruction Phase Services necessary to establish a GMP as well as all Construction Phase Services following Award of the GMP. The Construction Manager shall provide services to incorporate all of the requirements set forth in the Permitted Construction Documents, State Requirements for Educational Facilities, the Florida Building Code, Florida Fire Prevention Code, and the National Electrical Code.

Scope of work includes demolition of existing partitions, ceilings, and finishes throughout the second floor of the CFI building. Electrical systems will be demolished back to the panelboards. Construction totaling approximately 10,900 square feet will include new offices, office support, an ADA restroom, and IT/AV infrastructure. Modifications to existing mechanical and fire protection systems will be isolated to those areas impacted by new office configuration. The building will remain occupied during construction. An existing service elevator will be utilized for access.

TCC intends to select a firm for this specific project on TCC's Center for Innovation Campus in Leon County. The firm must be a licensed general contractor in the State of Florida and meet all other requirements as may be required by law and this RFQ.
