


We cherish our open door policy because we believe that education has the power to change lives, but it would not be possible without a little help from our friends.

# To Our Community,

This year's annual report is full of stories that outline the great work being done to support students at Tallahassee Community College. Our work focuses on three areas: scholarships, program enhancements and facility upgrades. You have helped us achieve great success in each of these areas.

Scholarships are a key to providing access and opportunity. This year, the Foundation launched the Gadsden LEARN Scholarship for graduating high school seniors of Gadsden County to attend TCC. I would like to thank Jim Rodgers and Mark Bates for their vision in creating this scholarship, and thank the many donors that made it possible. Through these efforts we were able to provide over \$25,000 in scholarship funds for this initiative.

Program enhancements are wonderful assets to our faculty and students. Our President's Circle has supported a variety of program enhancements, including the Provost's iPad Project, the College Innovation Fund Grants and the Digital Rail Project. The President's Circle has also purchased solar-powered charging tables for our students. The President's Circle celebrated its 10th anniversary this year – and we are so very grateful to them for their support of student success at TCC.

Facility upgrades help us ensure that our learning environments are innovative and engaging and support student success. Classrooms are the most critical place for student learning, and our First Class Project launched the renovation of 10 new classrooms this year. A forward-thinking and innovative environment requires comfortable furnishings, a vibrant atmosphere and dynamic technology. Many donors supporting these renovations are alumni and families of alumni – and we have confirmed funds to renovate 40 of the 50 classrooms for our project. Thank you to the families of Joe and Mary Pankowski, Larry and Vicki Kubiak, and Wayne and Betty Edwards for their support of these efforts.

# Year in Review

From across our three-county region and beyond, this year *you* helped us ensure that all students in our area had the opportunity to obtain an excellent education and access to the support they needed to succeed. Here are just a few of this year's many special stories.

## SUMMER

The Tallahassee Community College Foundation awarded more than \$600,000 in scholarships for the upcoming year. These awards provided critical funds to support more than 700 students.

The Foundation hosted Eagles RISE, TCC's annual back-to-school event for faculty and staff. Employees were recognized for their service to the College, and the annual RISE awards were presented to those that go above and beyond their jobs in helping students.

## FALL

The renovated and renamed Refreshment Services Pepsi & Vending Athletic Training Center was unveiled for TCC coaches and athletes. Funds donated by Refreshment Services Pepsi & Vending were matched by the TCC President's Circle to complete this renovation.

The Building Legacies Women's Leadership Series featured four sessions centered on the theme "Women Who Lead, Serve and Inspire." Proceeds provided \$10,000 to support the Building Legacies Scholarship.

The College Innovation Fund awarded \$30,000 this year in support of innovative projects like the Digital Rail Project, creation of a Mobile Material Strength Laboratory, Merit Pages for TCC student recognition, and TCC Preview Day for high school seniors.

The TCC Alumni and Friends Association launched TCC Day, an alumni outreach and recruiting effort in the fall. Visits were made to Tallahassee Memorial Healthcare and Capital Regional Medical Center, where staff visited with alumni, community members and prospective students.

The TCC Foundation hosted Westminster Oaks Day at TCC for residents in early October to learn more about how they can get connected with the College's programs and students. The visit was part of new partnership between TCC and Westminster Oaks that includes lifelong learning opportunities and volunteer activities.

Signature Seat donors were hosted by the TCC Foundation at two Theatre TCC! opening night receptions in the fall. Attendees got a chance to mingle with the productions' directors, artistic directors, costume directors, etc., and well as theatre program instructors for the shows "The Laramie Project" and "Taming of the Shrew."

TCC Foundation scholarship recipients and donors connected at our annual scholarship luncheon in October. The more than 150 who attended this year's event heard from Brandie Callaway, a student veteran who received the alumni scholarship. Dr. Larry Kubiak also spoke about his family's newly created scholarship that will provide funds for students that are the first in their family to attend college.

TCC healthcare scholarship recipients and donors were treated to a reception at the TCC Ghazvini Center for Healthcare Education. Donuts with Donors festivities included the announcement of the dedication of the Tallahassee Memorial HealthCare Auditorium and Tallahassee Memorial HealthCare Nursing Lab. Attendees also heard from Jonathan Flagg, a student veteran and recipient of a TMH Scholarship.

The TCC President's Circle celebrated its 10th anniversary this year. Over the last decade, this group has invested almost \$1M that has been instrumental in providing funding for projects such as the Pankowski Honors Lounge, the Lei Wang STEM Center, the Oyster Aquaculture Program at the Wakulla Environmental Institute and the College Innovation Fund.

TCC One Percent Club members were treated to a special thank you gift in acknowledgement of their generosity this year. A commemorative brick was placed in each member's name around Louis Hill Sr. Memorial Garden at year's end.

Investors, friends, faculty and staff of the College were invited by the TCC Foundation to mark the year's end at the annual Holiday Hob Nob. It is one of the best ways we know to thank those who have been so generous in their support of our mission and our institution.





Each year, the TCC Alumni and Friends Association recognizes individuals who have achieved outstanding success and made a lasting impact on their community. This year, 16 members were inducted into the TCC Alumni and Friends Hall of Fame:

- **James Kassaga Arinaitwe** (class of 2006) – Co-Founder and CEO of Teach for Uganda. Formerly with the Carter Center and a Global Health Corp Fellow in New York City.
- **Eddie Barnes** – Retired TCC basketball coach with an overall NJCAA record of 274-144. Considered the dean of Panhandle Conference coaches.
- **Pamella J. Butler** (class of 1977) – Founder and chair of Aegis Business Technologies. As TCC Foundation Board chair, spearheaded TCC. We Rise Campaign, raising \$14.4 million in 2016.
- **Jean English-Hurst** – Founding director of the TCC Theatre Program. Established the Ralph and Jean Hurst Gallery through the donation of their private art collection.
- **Marm M. Harris** – TCC’s second president, created the Artist Series and built the Lifetime Sports Complex.
- **James H. Hinson, Jr.** – TCC’s third president. Tenure marked by strong legislative funding support; reestablished the athletic program; tripled the size of campus; established and opened the Gadsden Center, a new library, and the Academic Support and Extended Studies departments.
- **Betty Jensen** (class of 1977) – Served at TCC for nearly 30 years. Established the International Student Services department and the awarding-winning International Student organization. Developed the TCC International Education Week and the Florida International Leadership Program.
- **Ken Katsaris** – Developed TCC’s original criminal justice education program in the late 1960s. Chaired the Criminal Justice program until 1977, when he was elected Leon County sheriff. Has taught basic recruits at FPSI at TCC since 1999.
- **William D. Law, Jr.** – TCC’s fifth president. Opened the Economic and Workforce Development Center and the Learning Commons. Broke ground on the Ghazvini Center for Healthcare Education. Expanded the Florida Public Safety Institute.
- **Kimberly A. Moore** (class of 1993) – Current vice president for workforce innovation at TCC. Previously served as CEO of WORKFORCE Plus—the youngest person, the first African-American and the first woman to hold that position. She is a member of the Board of Trustees of Florida A & M University.
- **Deborah Robinson** – Served as the director of library services at TCC for six and a half years. Known for her passion for helping students. She passed away in June 2017 after a brief illness.
- **Chris Summers** (class of 1983) – Served in the Tallahassee Police Department for 27 years before becoming chief of police at TCC. Serves as an adjunct instructor at FPSI. Joined the command staff of Leon County Sheriff’s office in January 2017 as chief of the Department of Law Enforcement.
- **Beth Willis Tedio** (class of 1978) – A lifelong volunteer who currently works as the director of development at Lee’s Place. She is also co-owner of Uptown Café, where she has created Uptown Cares, a monthly program that provides public awareness and donations to local nonprofits. She is a member of the TCC Foundation Board and past chair of the TCC Alumni & Friends Association.
- **Marjorie R. Turnbull** – Served as executive director of the TCC Foundation and vice president for institutional advancement from 1995 to her retirement in 2006. Spearheaded growth in TCC Foundation assets from \$250,000 to more than \$10 million.
- **Fred W. Turner** – Founding president of TCC. Responsible for planning and building from the ground up, writing the curricula and course descriptions, and hiring faculty and staff—among numerous other responsibilities. Students were always his highest priority.
- **T. K. Wetherell** – TCC’s fourth president. Credited with overseeing TCC’s growth and evolution into one of the state’s premier community colleges. Doubled the square footage of the campus; added 50 major workforce development programs and a web-based Associate in Arts degree; oversaw further development of the Florida Public Safety Institute and significant technology innovations.



## SPRING

Thanks to supportive donors, four new scholarships were created at TCC over the Spring. Each covers both the Associate in Arts and Associate in Science programs, as well as programs offered by Workforce Development:

- *The Big Bend Law Enforcement Association Scholarship provides financial assistance to descendants of law enforcement officials.*
- *The Panacea Waterfronts Partnership Scholarship was created for residents of Panacea by the Panacea Waterfronts Florida Partnership.*
- *The Rotary Club of Tallahassee Leon Gilchrist Scholarship helps residents of a Big Bend Habitat for Humanity home attend TCC.*
- *Tracey and Jeremy Cohen created the Target Print and Mail Scholarship fund for students who are pursuing a degree in Business or Marketing. It was established to aid in the Cohens' mission of reducing unemployment in the local area, and preference is given to those who plan to remain here after graduation.*

Friends of the College gathered for our third annual Cleaver and Cork signature fundraiser – another sold-out affair. This year's event featured celebrity Chef Amanda Freitag. Proceeds were matched, bringing the total raised to more than \$100,000. Funds will be used to renovate two TCC classrooms.

TCC investors were treated to our first ever Thank-a-Thon Week this spring, with special deliveries of cookies, candy, thank you videos, and special messages from TCC students and President Jim Murdaugh.

More than 300 runners and walkers gathered for the third annual Hops and Half Shells 5k Trial Run/Walk in April, hosted by the TCC Foundation. Participants were treated to oysters farmed by WEI's Oyster Aquaculture program, as well as local craft beer. Proceeds support programs and scholarships for WEI.

The First Class Project unveiled the first eight fully renovated classrooms. The rooms unveiled this spring included The Andrews, Crabtree, Knox & Longfellow Classroom, The Donna and Jimmie Callaway Classroom, The PDJ Classroom, The Thomson Brock Luger & Co. Classroom, The Aegis Business Technologies Classroom, The Mitchell Family Classroom, The Monte Finkelstein Classroom, and the Pankowski/Rae Family Classroom.



The TCC Foundation hosted an event in May to celebrate the College's retirees. This special luncheon included fellowship with past co-workers and the opportunity to visit with President Jim Murdaugh and his wife Sara Murdaugh.

Theatre TCC! presented "Schoolhouse Rock" during the spring and Signature Seat Donors were hosted by the TCC Foundation just before the opening night performance. Attendees met and mingled with the production's directors, artistic directors and costume directors.

This year's ONE Campaign, conducted by our Alumni & Friends Association, raised just over \$21,000. These funds support our alumni programs and scholarships on campus.

TCC's Eagle Legacy Society held its annual luncheon in May. This society includes those that have left a planned gift to TCC. Held at the Governor's Club, investors were thanked and honored by President Jim Murdaugh and TCC Foundation President Curtis Richardson.

# Grants

2017 - 2018

Grants are incredibly important as they provide funding for programs that would not otherwise exist. Grant applications often require matching funds that can be provided by the Foundation—another reason why our work is so important.

## SOME OF THE GRANTS AWARDED TO TCC THIS YEAR:

**Troops to Teachers Grant** from the Department of Defense. TCC has been awarded more than \$1.7 million for a five-year statewide grant. Through an agreement with the Florida Department of Education, TCC will counsel service members and veterans on the best route to become certified and employed as a K-12 teacher.

**Florida Consortium on Inclusive Higher Education for Student Affairs Grant** for \$58,500. This grant allows us to expand our Eagle Connections program, a postsecondary transition program designed to facilitate the social and academic integration of students with intellectual disabilities with nondisabled students.

**Gulf of Mexico Oyster Aquaculture Small Grants Funding Opportunity** for TCC's Wakulla Environmental Institute. This \$69,674 grant allows for experimentation with different oyster growing methods and spat retention in Oyster Bay and the purchase of several different growing systems for testing on the WEI management site.

\$49,754.82 for creation of a **Victim Advocate Program** through a grant from the State Attorney's Office. The Victim Advocate provides crisis and short-term counseling as well as assistance with any problems victims or witnesses may experience because of the crime itself or as a result of the victimization.

\$97,500 from the **COCA Cultural Facilities Matching Grant Program**, for a major upgrade of the lighting, sound, projection system and stage equipment in Turner Auditorium. The total projected cost is \$200,000, with half of that coming from that TCC Foundation.

**Entrepreneurship Program Network Partner Grant** from Veterans Florida for \$75,000. This program offers qualified veterans the opportunity to receive an entrepreneurship education. TCC is one of six network partners in Florida.
